





## Benguela, 23-24 May 2023

Following the successful first Angola-European Union Business Forum in Brussels in 2022, the EU in partnership with Angolan authorities will hold a second edition of the event in May 2023.

Since the first edition, Angola continues to improve its business environment, diversify exports and enhance the country's infrastructure. The EU and its Member States, as major trade and investment partners, are committed to support the reforms oriented towards economic diversification and growth, decent jobs creation and sustainability.

Part of the broader EU strategy to step up engagement through the "partnership of equals" approach, the European Commission concluded negotiations with Angola on a Sustainable Investment Facilitation Agreement (SIFA) – the first EU agreement of this kind - to further enhance sustainable trade and investment links in line with the Global Gateway. The agreement is designed to attract and expand investments while integrating environment and labour rights commitments in the Angola-EU relationship. It seeks to support the diversification of Angola's economy, currently based on its abundant raw materials and energy resources, to unlock the country's potential through inclusive and sustainable growth. In addition, Angola's accession to the African Continental Free Trade Area (AfCFTA) and the SADC Trade Protocol contribute critically to connecting Angola's economy to regional and global value chains.

The 2<sup>nd</sup> Angola-European Union Business Forum will highlight Angola's opportunities and comparative advantage as a strategic destination for direct investment, capitalising on public-private engagement, encouraging networking between Angolan and European businesses, facilitating investments, and sharing the experience of European firms in the strategic sectors of **agriculture and agribusiness**, **livestock**, **fisheries**, **digitisation and logistics**, whilst discussing measures for improvements.

The Business Forum will take place in Angola's province of Benguela given its link to two crucial infrastructures: the Lobito corridor, a crossroad anticipated to become central to the economy and trade between the Southern African Development Community (SADC) countries and the world, given the potential of its value chains, and the Lobito port, one of Africa's major ports.

## Format

The EU-Angola Business Forum is the second of a series of annual public-private dialogues around Angola's reform agenda on economic diversification, highlighting key successes and remaining challenges. It will be held in the province of Benguela on 23-24 of May 2023 and includes structured direct interaction between companies (B2B) and business to government (B2G). The event will also present a stocktaking of progresses and reforms made since the 1<sup>st</sup> EU Business Forum and draw new priorities and areas for joint intervention for the following years.
